

Terms&Use for Cosmosf M31 Plugin Software:

END-USER LICENSE AGREEMENT FOR EnVBot Plugin software IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: This End-User License Agreement ("EULA") is a legal agreement between **You** and **Sinan Bokesoy** for the **sonicLAB** software products identified above which may include associated software components, media, printed materials, and "online" or electronic documentation "Cosmosf M31".
